TRAINING OF CORPORATE AGENTS / AGENTS

A.Training Requirements For Corporate Agents / Bancassurance / Agents:

- The principal officer of the applicant should be a graduate and should have received at least fifty hours of theoretical and practical training and should have passed the examination.
- The specified persons of the applicantshould have passed 12th class or equivalent examination and should have received at least fifty hours of training for the specified category of life, general, health for which registration is sought. He should also have passed the examination and must hold valid certificate issued by the Authority under these regulations.
- Specified Persons and Chief Insurance Executives who are qualified and already working with a Corporate Agent duly licensed may continue to work. However, their details have to be submitted to the Authority and their certificates should be obtained.
- A Corporate Agent who intends to engage the services of a telemarketer or engage in distance marketing activities for the purpose of distribution of insurance products shall follow the instructions as laid down in Schedule VII of these regulations.
- An individual agent is required to undergo twenty-five hours mandatory training.
- The syllabus for training of agents / corporate agents has been prescribed by IRDAI and the IRDAI Agency Examination based on these courses is conducted by Insurance Institute of India, Mumbai in online mode at various centres all over the country. The present courses for this examination are as under:

Health Insurance - IC-32, Life Insurance - IC-33 and General Insurance - IC-34

 - (ii) Candidate can download the prescribed study course IC-32 / 33 / 34 and study the same. These books are in available in English / Hindi in printable PDF format.
 - (iii) After study of the book, the candidate has to attempt chapter wise online learning modules so as to familiarise himself with the subject and understand the nature of questions that may be asked. He is expected to spend 3-4 hours per during the period of training.
 - (iii) On completion of the learning, the candidate has to attempt the online mock tests allotted to him. These tests are single attempt online exam prepared on the pattern of actual exam.
 - (iv) After completing the online test, he can view his score and 'Analysis' sheet which contains the answers given by him as well as the correct answers (Key). Question papers is also available for online viewing. This helps the candidate in identifying his weak areas and refresh his learning by referring to the book. This way he can improve his performance.
 - (v) The performance of the candidate is evaluated on the basis of online mock tests assigned to him. Our experience shows that the candidates who have qualified in our mock tests, have also been able to pass IRDAI exam comfortably.
 - (vi) On qualifying the online tests, the Training Completion Certificate (**TCC**) is issued and the candidate can be enrolled for IRDAI exam.
